Construction of Multitier (Double tier) wire net cages

Terms & Conditions

1. Successful Tenderer(s) shall have to execute an Agreement with the Office of the KVK, Jalpaiguri, Ramshai on a Non-judicial stamp of Rs. 100/- (One Hundred) only within the date specified in the letter of intimation. The cost of Non-judicial Stamp Paper of Rs. 100/- is to be borne by the willing tenderer.
2. The intending Tenderers shall have to furnish documents like Trade License, Current IT Return, Credential, GST Registration, Professional Tax Clearance, PAN and other related documents at the time of application.
3. The rate should be quoted with inclusion of GST & other taxes applicable.
4. The intending Tenderer may contact the office for detail location of work before quoting / submitting the rate.
5. The Contractors / Organization those are engaged in construction of **Multitier Wire Net Cages** will only be eligible to participate in this Tender.
6. The successful Tenderer will supply the material of good quality as per the specification mentioned below the Terms and Conditions and fitting & fixing will be done properly.
7. The rate should be quoted in entire work up to completion. The Office will not incur any type of expenditure during entire period of construction and related activities.
8. No tender will be accepted without Earnest Money.
9. Each page of Tender shall be signed by the Tenderer before dropping it.
10. Name & address of the tenderer and the item for which tender is to be deposited should be super scribed in block letters on the top of the envelop.
11. The tenders, which do not fulfill any of the above conditions or incomplete in any respect are liable to be summarily rejected.
12. Payment will be made from the Office of the KVK, Jalpaiguri, Ramshai in such a manner that entire payment will be made after satisfactory completion of the work
13. The authority reserves the right to reject or accept any or all tenders without assigning any reason whatsoever.
14. The authority also reserves the right to choose any kind of item or items.
15. The authority is not bound to accept the lowest tender. Acceptance / Cancellation of the tender will depend solely on discretion of the authority and the authority is not bound to accept the lowest quotation if found unsuitable.
16. No claim for any subsequent increase in market price of anything more than the rates offered / quoted by the Tenderer shall be entertained.

17. In case of failure to complete supply work within the stipulated time, the earnest money and performance security will be forfeited without assigning any reason thereof.
18. The Earnest Money will be released to the unsuccessful tenderer after issuance of supply orders on application thereof.
19. A Work Order will be issued from the office of the undersigned after accepting the same. Tenderer must complete the work within stipulated time period as will be mentioned in the Work Order, failing which his tender may be cancelled and earnest money will be forfeited. No hike of rates will be allowed later on.
20. The Security Deposit in the form of Draft / DCR drawn in favour of KVK Jalpaiguri, Ramshai will be submitted at the time of agreement.
21. In case of successful tenderer, the Earnest Money will be released after successful completion of the work.
22. The Security Deposit Money will be refunded after successful completion of work.
23. In the event of tender being submitted by a firm, it must be signed by each member thereof and in the event of absence of any partner, it must be signed on his behalf by a person holding a power of attorney authorizing him to do so.
24. The tenders, which do not fulfill any of the above conditions or incomplete in any respect, are liable to be summarily rejected. Any deviation from the standard as required if found any time by the authority, the same will have to be replaced within specified time.
25. All papers shall be verified with the originals.
26. The Programme Coordinator & Co-PI of the project, Jalpaiguri Krishi Vigyan Kendra, WBUAFS reserves the right to issue Tender Forms / Documents and accept or reject any tender thereof without assigning any reason whatever and not to be bound to accept the lowest tender.

Details of the Work:

Multitier Net Cages: Double tier cages with wire net floor and walls with following specifications-

1. **Surface area** of Multitier Net Cage 24 sq. ft.
2. **Dimension:** Six (6) ft. length x Four (4) ft. width x Eight (8) ft. height
3. **Frame work:** Structure should be raised on good quality iron angle bars fixed with wooden frame of (1 inch x 3 inch) size. The top of the cage will be of wooden and asbestos covering. The walls of the cage will be made up of 1- 1.5 cm loop wire nets.
4. The cage will be set upon land with 1 ft. bars underground and a minimum of 2 ft height of lowest floor from ground should be there after fixing it.

5. Floor work: The floor of the cages will be made up of good quality 5-6 mm. small loop wire nets. Both the tiers of cage will be of Two and half (2.5) ft.
6. There should be a desk of good wooden frame of (1 inch x 3 inch) size covered with aluminum sheet structures that can be taken out easily below the upper tier of cage. The desk will be of size six (6) ft. length x Four (4) ft. width.
7. The cage should be provided with two electric bulb fittings in each tier of cage.
8. Each tier of the cage will be fitted with feeder and drinker made with good quality aluminum sheet (16/ 18 gauze) along the length of the cage (6 ft.) with depth of 3 cm.
9. Each tier of cage will be having two nest boxes in each. The nest boxes will be of size 1 ft. x 1 ft. x 1ft. made up of good wooden frame of (1/2 inch x 4 inch) size.
10. The doors for both the tiers should be made with wooden frame of (1 inch x 2 inch) sizes and same net as of the walls of the cage of height and width of 2.5 ft and 2 ft. respectively.

Sealed envelopes addressed to the Programme Coordinator, Jalpaiguri Krishi Vigyan Kendra, WBUAFS, Ramshai, Jalpaiguri one containing technical specification along with necessary documents and the commercial specification along with earnest money are required to be deposited super scribing the purpose clearly on the top of the sealed envelope.

Earnest money amounting to **Rs. 12,300/-** (Rupees Twelve thousand three hundred) only is to be deposited by open Bank Demand Draft / Deposit at Call Receipts drawn in favor of **WBUAFS Revolving Fund** payable at **Maynaguri** along with tender documents, without which the tender (commercial bid) will be treated as cancelled.
